### Vocational Educational Training (VET)

From 2022, the Department will reimburse VET material fees to government schools to address the cost barrier for families. This funding covers the costs of:

- Materials required for training and assessment that are consumed and cannot be recycled. **Please note students may wish to upgrade materials for certain projects (i.e., upgrade from pine to mahogany). Any upgrade from the materials provided by BHHS is considered an OPTIONAL ITEM.**
- Safety items worn or used by the student including safety glasses, hearing protection, gloves, hair nets.
- Workbooks, handouts, photocopying, online learning resources
- Class sets, intended to be returned and retained by the school, such as textbooks, tools, tool belts, specialist knives, aprons

However, this funding does not cover all costs associated with the facilitation of VET classes. Parents will still pay for some costs such as:

- uniform requirements or personal protective equipment, that are used and retained by the student
- PPE worn and retained by the student
- Online registration/subscription fees, platform charges, software
- Tuition fees, registration, and administration fees
- Tools upgrade or purchase initiated by the parent

Not all VET programs are eligible for reimbursement. Programs undertaken outside of the school curriculum and traineeships undertaken by students outside of school such as in a part-time employment arrangement, and Certificates in General Education or at Diploma level are all excluded.

### Payment methods

Parent contributions towards the requested payments is essential to maintain the quality of education that we provide at Box Hill High School. Parents are strongly urged to contribute to these funds and can be paid via:

- Compass Parent Portal – Preferred Method
- EFTPOS – Either call 03 9830 5099 or in person at the general office.
- Cash – In person at the general office
- BPAY – please refer to letter containing your families unique BPAY reference or contact the office

To access the Compass Portal

- Enter the following URL into the address line in your web browser. NB: Compass works best with Google Chrome. You can also access Compass via the Box Hill High School website homepage.

- Login to the Compass Portal using your **unique Parent Compass ID and your Password**.
- In the Compass Portal, click on the Organisation Tab/Student Management/**Course Confirmation Payments**. Click on the hyperlinked line to process your payment.
- Follow the Compass instructions and input your credit card details. You can choose to either "**Pay in full**" or "**Pay by Instalments**".
- If you choose to **pay by instalments**, then the instalments will be automatically processed on the following dates.
  - Instalment 1      7 February 2022
  - Instalment 2      14 March 2022
  - Instalment 3      11 April 2022

If you choose to **pay in full**, then the full amount will be deducted on the **same day** that you process your payment on Compass. If you need to change your Credit Card details on an instalment payment plan set up via Compass, you will need to contact the General Office to make these changes for you.

### Refunds

Parent requests for a refund in the event of an extra-curricular activity being cancelled are subject to the discretion of the school and made on a case-by-case basis. Refunds will be considered under the following conditions:

- Cancelled due to unforeseen circumstances
- In the event of serious illness or accident

Our arrangements with third-party providers are subject to conditions and will be assessed on a case-by-case basis.

Refunds will be provided where the school deems it is reasonable and fair to do so, **taking into consideration whether a cost has been incurred**, the Department's Parent Payment Policy and Guidance, Financial Help for Families Policy and any other relevant information.

# PARENT PAYMENTS POLICY

## ONE PAGE OVERVIEW



### FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the standard curriculum requirements in Victorian Curriculum F-10, VCE and VCAL.
- Schools may invite parents to make a financial contribution to support the school.



### PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

#### Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

#### Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

#### Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



### FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



### SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
